These out-dated conditions severely hamper mission performance, training, and troop morale. As such, units are broken up and forced to train out of state for extended periods which swells both costs and the loss of valuable collective training time normally reserved for annual training.

The funds will be used to complete the first phase of construction and will provide world-class facilities to support training for Engineers, Military Police, and Chemical Military Operational Specialties (MOS). The *Regional Training Institute* will make available opportunities for essential school house training to support Officers and NCO's in their pursuit for professional military education, such as the Officer Candidate School (OCS), and the Noncommissioned Officer Education System (NCOES). Further, the projected student numbers afforded by enhanced recruitment across the Missouri Guard and other "grow the force" initiatives require this new construction.

Last year the Missouri National Guard achieved over 100 percent strength by maintaining over 11,500 Soldiers and Airmen on the rolls. In light of the Missouri Guard's community-based economic framework, taxpayer dollars used to support military construction on Fort Leonard Wood fosters value-added economic benefits to communities throughout Missouri, as the money received is turned over several times in every segment of the state economy.

This request is to replace Dover Air Force Base's inadequate security forces complex with a facility that is adequately sized and properly configured to support the Security Forces' base protection and mobility missions.

Dover Air Force Bases' current security forces operate out of a 1960s vintage building originally constructed as a flying squadron operations facility. The out of date building provides insufficient work space and poor facility infrastructure. The armory is an inadequate size and does not meet forced entry standards, meaning that 24/7 manning is required to satisfy Air Force security measures. The current facility has no vehicle maintenance space, lacks storage and is undersized by over 60 percent for training, assembly and weapons issue rooms.

Due to the authorized manning increase in the aftermath of the September 11th terrorist attacks, the existing facility has become overwhelmed by personnel and is grossly inadequate for mission accomplishment. As a result, Dover's Security Forces Facilities are rated the second worst in Air Mobility Command due to deficiencies in facility space and functional need. Consequently, daily operations will continue to be hindered by overcrowding until a new complex is constructed.

If the committee provides Dover Air Force Base with \$14,000,000 in military construction funding for this project, the Air Force will construct an adequately sized and properly configured facility designed to support Dover's Security Forces' protection and mobility missions. A new facility will provide adequate storage for War Readiness materials, mobility equipment, and an armory for storage and issue of weapons and ammunition. Most importantly, the space will accommodate over 350 authorized active duty and active reserve security personnel.

For these reasons, I ask that the Committee provided Dover Air Force base with \$14,000,000 to replace their security forces complex and increase the base's security.

Evaluation mission. PMRF's North Loop electrical distribution system supplies power to the mission critical administrative and range operations support facilities. Facilities supported by the North Loop system include the water pump station, wastewater treatment plant, communications demarcation building, airport tower and crash fire, Theatre High Altitude Area Defense (THAAD) mission and maintenance buildings, weather station, range target boats, security buildings, eating establishments and other range user facilities.

Currently, the North Loop poles and overhead conductors, with a few exceptions, are from the World War II era, they are at end of their design life, and are in need of replacement. Failure to implement this project will impact the reliability of power to PMRF. Reconfiguration of the system from its current radial feed to a loop feed system will provide optimum system safety, decrease power downtime, increase ease of maintenance, and reliability.

However, I remain committed to the belief that America's advantages in space must be maintained. I also support several major weapons development and modernization programs for which stable funding is critical to technical progress and increased capabilities. Specifically, I support the Department's budget request to develop and procure the F-35 Joint Strike Fighter, the E-2D Advanced Hawkeye, the C-27J Joint Cargo Aircraft, the Littoral Combat Ship and the next generation ballistic missile submarine. We are writing to urge the Committee to authorize at least \$75 million in fiscal year 2011 for the Readiness and Environmental Protection Initiative (REPI) within the Operations and Maintenance, Defense-wide account.

Congress and the Department of Defense (DOD) have recognized that accelerating development, population growth, and loss of habitat on non-military lands pose a serious threat to the sustainability of key military installations, ranges, and airspace, and accordingly to military readiness and to the development and fielding of future weapon systems. In 2002, Congress provided the Secretary of Defense and the Secretaries of the Military Departments authority in section 2684a of title 10, US Code, to partner with state and local governments and conservation organizations to identify and protect key areas necessary to ensure the long-term sustainability of these vital installations, ranges, and airspace. The Secretary of Defense implemented this authority by establishing the Readiness and Environmental Protection Initiative (REPI).

The REPI program has already proven to be a great success. In fiscal years 2005 through 2009, DOD used REPI authority to provide over \$130 million to support installation projects and leveraged in excess of \$150 million in partner contributions. Congress and DOD provided an additional \$54.7 million in FY 2010 to protect key installations, ranges, and airspace through REPI, and these funds are leveraging significant additional funding from partners. Since FY 2005, REPI-funded projects have been or are being implemented at more than 50 installations and ranges throughout the country. Additional projects are expected to be initiated in the next few months.

Recent DOD and RAND Corporation assessments have validated the effectiveness of REPI, but also indicate that the program needs additional resources to meet the challenges that encroachment is posing to military installations and ranges. The RAND report, entitled "The Thin Green Line," concluded that the REPI program is underfunded, that opportunities for effective action to protect bases are being lost, and that the cost of effective action will only increase over time. RAND recommended a funding level of approximately \$150 million per year throughout the FYDP and beyond.

Over the last several years, Congress has taken steps to increase funding for REPI. We appreciate your leadership in helping increase FY 2010 funding for the program to \$54.7 million, \$18 million above the Pentagon's budget request, but still less than half of the Service-validated funding requirements. This year, the Administration has requested \$40 million for REPI. We believe that this is far too low to effectively meet the very real threat encroachment poses to the long-term viability of military installations across the country and to the readiness and economic benefits provided by those installations.

These challenges will only intensify in the near to mid-term. The "Grow the Force" initiative, the global restationing of forces, implementation of BRAC 2005, fielding of new weapons systems, and the pressing need to retrain forces as they redeploy from Iraq and Afghanistan will all increase pressures on our remaining military installations and ranges. We must get ahead of these pressures if we are to preserve readiness over time.

In our view, REPI needs to be funded at a level of at least \$75 million in FY 2010 if it is to continue to be successful in addressing encroachment, preserving the readiness of our Armed Forces, ensuring the long range sustainability of our installations, ranges, and airspace, and sustaining the vital contributions military installations make to our local, state, and regional economies. We respectfully encourage you to fund the Readiness and Environmental Protection Initiative at this level.

We understand that this will be a difficult budget year. However, the relatively modest investment in protecting our bases now under REPI is a highly cost-effective method of avoiding much higher expenditures in the outyears to attempt to overcome the impacts of encroachment if left unaddressed.

One of the major challenges facing the domestic industrial base is to maintain technology leadership in strategic sectors critical to our national defense, especially in light of growing global economic pressures and the threatened loss of technical and skilled manufacturing jobs. The Metal Affordability Initiative (MAI) consortium, established in 1999 has improved the military war fighting capability while reducing life cycle cost through technology innovation and is helping to transform the US specialty aerospace metals industry by increasing the competitiveness of this critical industrial sector.

MAI is a model for government/industry collaboration. The membership includes 19 companies, along with our government agency partner – the Air Force Research Laboratory (AFRL). Alcoa became a member of MAI this past year bringing additional aluminum technology expertise to the membership. In addition to the consortium members, MAI projects have involved participants from over 60 additional industrial companies, including over 45 small businesses, 18 universities, and 3 National Laboratories located in 35 states, truly a national program with regional relevance.

MAI allows leveraging of precious technical resources and financial investment. The government investment (over \$69-million to date) is supplemented by a minimum industry cost share of 25% plus production qualification costs. We can document a return on total government investment significantly greater than 10:1. MAI programs have already accomplished over 60 current or planned technology insertions into military systems. MAI is an outstanding example of good public policy.

The Air Force has recognized the excellent contribution of MAI to meeting their focused long-term challenges by continuously increasing support from limited discretionary funds (now up to \$25-mil through FY 2013) for developing advanced structural metals technology. Our long-range goal, working both with OSD and the Congress, is to establish MAI as a Defense-wide budget item in FY 2012.

Therefore, we respectfully request that the Committee authorize an additional \$10 million in FY11 to Advanced Materials for Weapon Systems, PE 0603112F, specifically for MAI. This funding will allow initiation of 4 new, more immediate high-impact programs, as well as sustaining ongoing programs. These new industry-led programs will be directed at improvement in total systems cost, fuel savings/energy management, “green” (environmental impact), and access to space.



The projects we wish to replace are Modifying Building 39 for Fleet S9G FIDE Trainer (P-048) and the Equipment, Maintenance, and Storage Facility for the Marine Corps at Pohakuloa (P-774). We respectfully request your consideration of the following projects in their place which are included in the Navy's FYDP. The corresponding Form DD 1391s are attached for your review.

Project: Construct Pre-Fabricated Bridge at Nohili Ditch
Request: \$4.26 million

Project Description:

This project will install a pre-fabricated, two-lane bridge and supporting appurtenances. Research for missile defense programs is conducted at the Kauai Testing Facility, which is located on the northern end of PMRF. The only access to the site is via Nohili Road which is subjected to large and heavy loads. There are signs of erosion along the sides of the current road and the adjacent banks of the drainage channel, which has been in existence since the 1920s. Without the replacement project, drainage system failure of the pipe coupled with current erosion problems could make the current bridge structurally unstable and lead to its collapse. Such a collapse would render access to the Kauai Test Facility in the northern part of PMRF inaccessible negatively impacting the base's mission.

Let us begin by thanking you and the entire Committee for your support of Gulf War Illness treatment research funding in last year's National Defense Authorization Act (NDAA). Because of your constant efforts and those of the Appropriations Committee, \$12 million was authorized and \$8 million was appropriated for the Gulf War Illness Research Program (GWIRP) within the U.S. Army's Congressionally Directed Medical Research Programs (CDMRP). This year we request that you provide authorization for \$25 million in funding for research focused on identifying beneficial treatments and diagnostic markers for veterans suffering from Gulf War Illnesses (GWI), the complex of chronic symptoms (including, among others, widespread pain, cognitive impairment, and persistent fatigue) resulting from service in the 1991 Gulf War. At least 175,000 veterans, one in four of those deployed, are affected.

This request has the support of the Air Force Association, the American Legion, AMVETS, the Association of the United States Army, the Association of the United States Navy, the Blinded Veterans Association, the Disabled American Veterans, the Enlisted Association of the National Guard of the United States, the Fleet Reserve Association, the Military Officers Association of America, the National Association of State Directors of Veterans Affairs, the National Association for Uniformed Services, the National Guard Association of the United States, the National Gulf War Resource Center, the National Vietnam and Gulf War Veterans Coalition, the Naval Enlisted Reserve, the Paralyzed Veterans of America, the Reserve Officers Association, The Retired Enlisted Association, the Veterans of Foreign Wars of the United States, the Veterans of Modern Warfare, Veterans for Common Sense, the Vietnam Veterans of America, and the U.S. Coast Guard Chief Petty Officers Association.

This request for \$25 million is only a portion of the \$40 million recommended by the November 2008 454-page report by the Congressionally-mandated Research Advisory Committee (RAC) on Gulf War Illnesses, which concluded that "[t]he extensive body of scientific research now available consistently indicates that Gulf War illness is real, that it is the result of neurotoxic exposures during Gulf War deployment, and that few veterans have recovered or substantially

improved with time.” A 2009 VA-DoD-supported study confirmed these findings, noting that “about 25% more Gulf War veterans reported suffering from MSI [Multi-symptom illness] compared with their Gulf Era military peers.” The RAC report called for a “renewed federal research commitment ... to identify effective treatments ... to achieve the critical objectives of improving the health of Gulf War veterans and preventing similar problems in future deployments.”

Retired U.S. Army General Eric K. Shinseki, the Secretary of the Department of Veterans Affairs (VA), last month announced that the VA intends to revisit the rejected claims of Gulf War veterans for health and disability benefits. This action is a welcome acknowledgement of this major veterans’ health problem. What ill Gulf War veterans want most, however, are treatments to improve their health, and no effective treatments currently exist.

Treatment research is the focus of the CDMRP program. Because the program is funded by the Department of Defense, it is open to all researchers, enlisting the full scientific community in this effort, whereas VA research programs are limited to VA researchers. DoD has historically funded two-thirds of GWI research, reflecting the need to prevent similar problems in future deployments. However, funding for new Gulf War illnesses research has been eliminated from the DoD budget since the onset of the current wars. Only through the action of Congress has this vital program been maintained. Members of Congress of both parties have agreed that DoD, as well as VA, has a moral responsibility and a vested interest in funding treatment research.

Funding at the \$25 million level will support pilot studies to identify effective treatments and diagnostic tests and provide funding for clinical trials of treatments identified as effective in previous pilot studies. With its independent, merit-based, and peer-reviewed process we are confident that these resources are and will continue to be used in the best interest of our service members and veterans.

Unfortunately, exposures to toxins, chemical weapons, and other hazardous substances are a permanent reality for our service members. We need to make sure we have effective defensive measures and treatments in place for affected service members.

Finally, we certify that none of us individually nor our immediate family has a pecuniary interest, consistent with the requirements of paragraph 9 of Rule XLIV of the Standing Rules of the Senate, in this programmatic request we are making for inclusion in the FY11 NDAA.

Thank you for your consideration of this request and for your work on behalf of the members of our Armed Forces, our veterans, and their families. We look forward to working with you to ensure that \$25 million in authorization of funding for CDMRP’s Gulf War Illness Research Program is included in the Senate’s FY11 NDAA.
